

L-3 Liquid Algaecide

ACTIVE INGREDIENT:

Poly(oxyethylene (dimethyliminio) ethylene-
(dimethyliminio) ethylene dichloride) 10.0%

INERT INGREDIENT 90.0%

This product contains 0.85 lb. of active ingredient per gallon and weighs 8.49 lb. per gallon.

DIRECTIONS FOR USE GENERAL CLASSIFICATION:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

L-3 Liquid Algaecide is used to control algae, bacteria, and fungi in recirculating commercial and industrial water cooling towers. Prior to its use, systems must be cleaned of algae growth, microbiological slime, and other deposits. An initial slug dose of 16.13 to 15.32 fluid ounces of L-3 Liquid Algaecide per 1000 gallons of water provide a concentration of 48 to 120 parts per million of L-3 Liquid Algaecide based on the total weight of water in the system is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 16.9 to 32 fluid ounces of L-3 Liquid Algaecide per 1000 gallons of water (16.9 to 32 parts per million of L-3 Liquid Algaecide) should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the amount of bleedoff and the severity of the microbial problem. Slug additions should be made in the sump of water cooling towers.

L-3 Liquid Algaecide is used to control bacteria in industrial air-washing systems that maintain effective mist eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 24.7 to 41.2 fluid ounces of L-3 Liquid Algaecide per 1000 gallons of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 16.9 to 41.2 fluid ounces of L-3 Liquid Algaecide per 1000 gallons of water should be employed each 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or to the water collection trays of the airwash system.
