PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist, and provide adequate ventilation of area being treated. Do not use as a space spray. Avoid contact with skin, eyes or clothing. Wash hands thoroughly after handling. Do not contaminate food, utensils or food preparation areas. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially processed or prepared. Do not use in serving areas while food is exposed. Remove pets and cover fish bowls before spraying.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS:

EXTREMELY FLAMMABLE. Do not use or store near fire, sparks or heated surfaces. Turn off pilot lights in gas appliances and unplug or turn off electrical equipment in the use area. After airing out phase is completed, relight pilot lights and reconnect electrical current. Do not smoke in the use area. Contents under pressure. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Incineration of container may cause explosion.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USING! Hold container upright, and point spray nozzle away from you. Spray infested surfaces until wet. Spray residue kills insects after the spray has dried.

INDOOR USES: To kill cockroaches, crickets, silverfish, spiders, ants, scorpions, waterbugs: Spray into cracks around baseboards and places where insects hide. Spray behind and beneath cabinets, refrigerators, sinks, stoves, in and around waste containers. Repeat as required. Do not spray foodstuffs or house plants.

For ants, spray trails and places where ants enter premises. Do not allow children or pets to contact treated areas until spray is completely dry.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying of pet area. Do not spray animals with this product.

OUTDOOR USES: For the control of ants, clover mites, crickets, earwigs, fleas, millipedes and brown dog ticks. Spray infested areas thoroughly, including outside surfaces of screens, doors, window frames, foundations, patios and other places where insects may enter. Repeat as necessary. Do not spray vegetation.

STORAGE AND DISPOSAL

STORAGE: Store in a cool area away from heat or open flame.
PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Replace cap and discard container in trash. Do not puncture or incinerate.
