TO KILL FLIES, MOSQUITOES SMALL FLYING MOTHS, GNATS: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray for 5 to 10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly bc/ore relentry. Sweep up and destroy fallen insects. Before spraying cover exposed food and utensils.

TO KILL COCKROACHES, ANTS AND CRICKETS: Contact as many insects as possible with the sprav in addition to thorough spraying of all parts of the room suspected of harboring these pasts. Special attention should be paid to cracks, hidden surfaces under sinks behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, and trails and other areas of entry. Repeat as necassary.

TO KILL CARPET BEETLES: Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.

TO KILL EXPOSED FORMS OF CONFUSED FLOUR BEETLES, SAW-TOOTHED GRAIN BEETLES & RICE WEEVILS: Find and destroy infested package goods. Remove all other items from pantry. Spray shelves to kill any of the named insects present. Place clean paper on the shelves and return packages after shelves have dried. Repeat as necessary.

TO KILL SOWBUGS, CENTIPEDES, FIREBRATS AND SPIDERS:

Contact as many insects as possible with spray. Also thoroughly spray all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden surfaces, under sinks, behind stoves and refrigerators.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and destroy old pet bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floor. Repeat as necessary. Do not spray animals. Put fresh bedding in pet quarters after spray has dried. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area.

STORAGE AND DISPOSAL

STORAGE: Store in a cool area away from heat or open flame. DISPOSAL: Do not reuse empty container. Wrap container in newspaper and put in trash.
