

> IN THE PRODUCTION AND PROCESSING OF MUSHROOMS: To control flies or fungus gnats in mushroom growing houses, apply at a rate of 1 ounce per 1000 cubic feet of space. Fogger should be operated 8 to 10 feet away from beds and directed slightly upward over them. Circulating fans should be left in operation, but for best results, refrigeration should be turned off. In packing and canning plants, use a rate of 1 ounce per 2000 cubic feet of space.
