DIRECTIONS FOR USE (Continued)

INDOORS

Space Spray: To kill houseflies, mosquitoes, and gnats; Close room or area to be treated. Shut off air conditioner and ventilator system. Seal all open vents. Remove fish and pets. Apply undiluted as a very fine mist space spray through manually operated equipment or with electrical and other powered applicators. Avoid staining by holding the spray nozzle at least 5 ft. from objects. Direct the line spray mist toward the upper corners of the room. Fill the room with a fine mist space spray at the rate of 5 fl, ozs. per 5,000 cu. ft, Leave room closed for one-half hour. Ventilate thoroughly before re-entry. Sweep up and destroy insects. Contact Spray: To kill cockroaches, fleas, ants, crickets, silverfish, earwigs, spiders,

grain mites, sowbugs, centipedes and millipedes. Adjust spray to produce large wetting-type spray particles. Direct spray to contact these insects in cracks and crevices in floors, baseboards, around pipes, behind cabinets, and other harborages. Spray these infested areas until thoroughly wet. Repeat as necessary.

To kill bedbugs: Apply as a spot treatment to cracks and crevices around baseboards, floorboards, bedboards and walls. First, thoroughly clean and air mattresses and springs.
