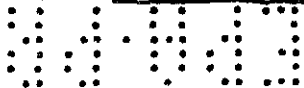
DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To Operate: Hold container upright, nozzle away from you and spray infested surfaces only until wet.

Roaches, Ants, Waterbugs, Silverfish, Spiders, Crickets: Spray heavily into all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks and stoves. Spray other localized areas infested with these pests. Repeat treatment as required. Do not spray foodstuffs or house plants. Do not allow children to contact treated surfaces until surfaces are completely dry.

Fleas and Brown Dog Ticks: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Allow the sprayed areas to dry thoroughly. Applications should be repeated as infestations warrant and reinfestation occurs. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

Fleas, Mosquitoes, Wasps, Hornets and Flying Moths Outdoors: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. Repeat treatment as necessary. For control of Wasps and Hornets apply after dark when all of the insects have returned to the nest. Repeat if necessary.

Fleas, Ants, Brown Dog Ticks, Clover Mites, Earwigs, Crickets, Millipedes Outdoors: For treatment of localized infestations of these insects in outdoor areas or where these insects may enter the dwelling, spray infested areas thoroughly. For Ants, thoroughly wet hills and runways. For Fleas and Brown Dog Ticks, spray weeds and bushy non-crop vegetation. Repeat treatment as necessary. Do not spray desirable vegetation.
