TO OPERATE: Hold container upright, and point spray nozzle away from you. Spray infested surfaces only until wet.

ROACHES, ANTS WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily into cracks around baseboards and places where insects hide. Spray until wet behind and beneath cabinets, refrigerators, sinks and stoves. Repeat as required.

FLEAS AND BROWN DOG TICKS: Thoroughly spray sleeping quarters of household pets, infested areas around baseboards, window and door frames, wall cracks and localized areas of floors and floor coverings. Allow to dry. Repeat as infestations occur. Replace bedding. Do not treat animals with this product. To control the source of flea infestations, treat pets with an insecticide product registered for use on animals.

FLIES, MOSQUITOES, WASPS, HORNETS AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray surfaces of screens, doors, window frames or where insects enter room. Treat surfaces where insects alight or congregate. Repeat as necessary. For control of **WASPS AND HORNETS**, apply after dark when all insects have returned to nest. Repeat as necessary.

FLEAS, ANTS, BROWN DOG TICKS, CLOVER MITES, EARWIGS, CRICKETS, MILLIPEDES OUTDOORS: Spray thoroughly outdoor areas where insects enter dwellings. For **ANTS**, thoroughly wet hills and runways. For **FLEAS AND BROWN DOG TICKS**, spray weeds and bushy non-crop vegetation. Do not spray desirable vegetation.

DISPOSAL: Replace cap and discard container in trash. Do not puncture or incinerate.
