**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION

STORAGE AND DISPOSAL

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling

ROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily into all cracks, around baseboards and other places where insects hide. Also behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

CARPET BEETLES: Make localized applications to the floor and baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat as necessary.

BROWN DOG TICKS: Thoroughly spray infested areas around baseboards, windows, and door frames, wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. **DO NOT TREAT ANIMALS WITH THIS FORMULATION**

FLIES, MOSQUITOES, WASPS, AND FLYING MOTHS OUTDOORS: For outdoor, use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or where insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

FLEAS, ANTS, BROWN DOG TICKS, CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES OUTDOORS: For treatment of localized infestations of these insects in outdoors areas or where these insects enter the dwelling, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat treatment as necessary. Do not spray vegetation.
