- c. Add "This (4 gram) product may only be used on dogs weighing between 14 and 29 pounds. May not be used on dogs weighing less than 14 pounds, or greater than 29 pounds."
- d. Add "This product is slow-acting", or "Takes a few days to show effects."
- e. Revise the statement "Kills fleas for up to 5 months" to read "Controls fleas for up to three months."
- f. Revise the statement "Kills ticks for up to two months" to read "Controls Brown dog ticks for up to one month."
- g. Revise the statement "For maximum population control of fleas and ticks, it is necessary to treat not only the pet but also its environment" to read "For control of fleas and ticks, it is necessary to treat not only the pet but also its environment"
- h. Delete the statement "Provides continuous long term protection against pests". These are heightened efficacy claims.
- i. Delete the statement "Repels Mosquitoes and Biting Flies". There were no data submitted to support these claims.
- j. Delete the statement "Full protection against hard-to-kill ticks will build up within a few days and will last for up to 2 months". Insufficient data were submitted to support these claims.
- k. Delete the term "Waterproof". There were no data submitted to support these claims.
- l. Under Storage and Disposal change "STORAGE" to "PESTICIDE STORAGE".
- m. In the warranty statement change "Y-Tex Corporation makes...". to "To the extent consistent with applicable by law, Y-Tex Corporation makes...".
- 3. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions.



# YT-1601 Dog Tag

The YT-1601 Dog Tag contains a powerful synergized pyrethroid insecticide that kills adult fleas and all blood-feeding stages of ticks, yet exhibits very low toxicity to animals and humans.

READ ENTIRE LABEL BEFORE EACH USE.

#### **DIRECTIONS FOR USE:**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not use on puppies less than 6 months of age or on dogs less than 14 pounds. For dogs weighing 14-29 pounds, use one 3.5 gram attachment, for dogs weighing 30-70 pounds, use one 7.5 gram attachment. For improved efficacy on dogs weighing over 70 pounds, you may apply two 7.5 gram attachments.

Remove attachment from package and attach to "D-ring" on existing collar using provided connector. The attachment must swing freely from the "D-ring". Consult a veterinarian before using this product on debilitated, aged or medicated animals. If used on pregnant or nursing dogs do not replace attachment until puppies are at least 6 weeks old. Sensitivity may occur after using ANY pesticide product for pets. Any pesticidal collar or collar attachment may irritate some animals. If irritation continues, remove the attachment from the animal. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Full protection against hard-to-kill ticks will build up within a few days and will last for up to 2 months. Protection against fleas will last for up to 5 months. As the YT-1601 Dog Tag is depleted of insecticide, ticks and fleas may be again noticed on your pet, indicating it is time to replace the attachment.

DO NOT USE ON CATS. The safety of this product has not been determined on cats.

#### STORAGE AND DISPOSAL

Store in a cool place in original container.

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store in cool place away from direct sunlight.

**PESTICIDE DISPOSAL:** Wrap used collar attachment in a plastic bag or several layers of newspaper and discard in trash.
