Your submission dated September 26, 2011

The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

1. Add a re-application interval or state product longevity as 4 months.
2. The following claims are acceptable:
"Controls fleas for up to 4 months."
"Controls brown dog ticks for up to 4 months."
"Aids in control of American dog tick for up to 4 months."
3. Change "Controls Lone Star ticks for up to 3 months" to "Aids in control of Lone Star ticks for up to 4 months."
4. Change "For application to dogs weighing 14-29 lbs. (4 gram medallion)" to "For application to dogs weighing 14-29 lbs. (4 grams medallion)"
5. Change "For application to dogs weighing over 29 to 55 lbs. (6 gram medallion)" to "For application to dogs weighing 30 to 55 lbs (6 grams medallion).


6. Change "For application to dogs weighing over 55 lbs. (8 gram medallion)" to "For application to dogs weighing 56 lbs. or greater (8 grams medallion)"

The YT-1601 Dog Tag is a collar medallion that contains a powerful synergized pyrethroid insecticide that kills adult fleas and all blood-feeding stages of ticks, yet exhibits very low toxicity to animals and humans.

READ ENTIRE LABEL BEFORE EACH USE.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Alternate wording used for 4 gram medallion:

Do not use on puppies less than 6 months of age. For dogs weighing 14 - 29 pounds, use one 4 gram medallion. This 4 gram product may only be used on dogs weighing between 14 and 29 pounds. May not be used on dogs weighing less than 14 pounds or greater than 29 pounds. This product takes a few days to show maximum efficacy.

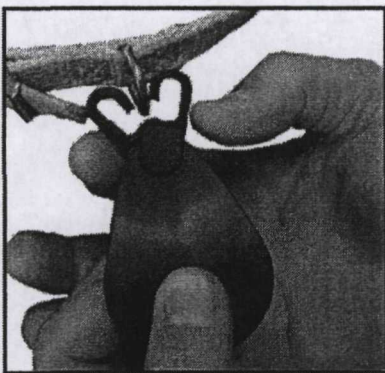
Alternate wording used for 6 gram medallion:

Do not use on puppies less than 6 months of age. For dogs weighing greater than 29 - 55 pounds, use one 6 gram medallion. This 6 gram product may only be used on dogs weighing greater than 29 to 55 pounds. May not be used on dogs weighing less than 29 pounds or greater than 55 pounds. This product takes a few days to show maximum efficacy.

Alternate wording used for 8 gram medallion:

Do not use on puppies less than 6 months of age. For dogs weighing greater than 55 pounds use one 8 gram medallion. This 8 gram product may only be used on dogs weighing greater than 55 pounds. May not be used on dogs weighing 55 pounds or less. This product takes a few days to show maximum efficacy.

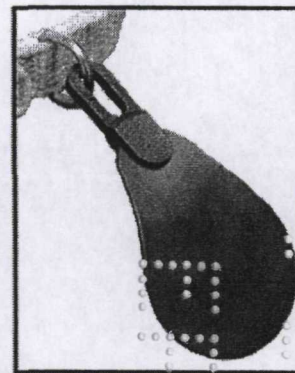
Remove medallion from package and attach to "D-ring" on existing collar as illustrated in Steps 1 through 3.



STEP 1 Open clasp and slide both halves around "D" ring on collar.



STEP 2 Close clasp and press together until it clicks into place.



STEP 3 When properly closed both halves should line up over each other.

The completed medallion must swing freely from the "D-ring" on the collar. Consult a veterinarian before using this product on debilitated, aged or medicated animals. If used on pregnant or nursing dogs, do not replace medallion until puppies are at least 6 weeks old.

Sensitivity may occur after using ANY pesticide product for pets. Any pesticidal collar or collar attachment may irritate some animals. If irritation continues, remove the product from the animal. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. As the YT-1601 Dog Tag is depleted of insecticide, ticks and fleas may be again noticed on your pet, indicating it is time to replace the attachment.

DO NOT USE ON CATS. The safety of this product has not been determined on cats.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

PESTICIDE STORAGE: Store in a cool place in original container, away from direct sunlight.

PESTICIDE DISPOSAL: Wrap used product in a plastic bag or several layers of newspaper and discard in trash.

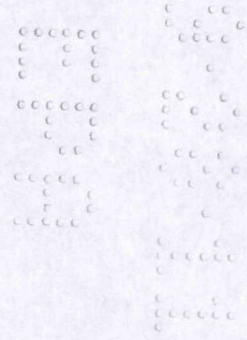
