
It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This labeling must be in the possession of the user at the time of pesticide application.

Resistance-management Recommendations. For resistance management, YT-1604M Insecticide Cattle Ear Tag contains a Group 3A/Zeta-cypermethrin insecticide. Any insect population may contain individuals naturally resistant to YT-1604M Insecticide Cattle Ear Tag and other Group 3A insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly in the same herds. Appropriate resistance management strategies should be followed. Monitor after application for unexpected target pest survival. If the level of survival suggests the presence of resistance, consult with your local university specialist or certified pest control advisor.

Calves under 3 months of age should not be tagged or ear damage may result.

Apply one (1) tag per head to the front or back of one ear on each animal to control most strains of horn flies and to aid in the control of face flies, stable flies, and house flies for up to 4 months. Apply when listed flies appear in the spring. For lice protection through winter, apply one (1) tag per head in late fall or early winter. Controls biting lice and aids in the control of sucking lice for up to 3 months.

Apply as shown with the Y-TEX 2 piece tagging system. All mature and weaned animals in the herd should be tagged to avoid dilution of the treatment. For optimum pest control on Brahman-type cattle with large ears, apply tags to the back of the ear. To minimize development of insecticide resistance, remove used tags at end of fly and lice season, and follow Y-TEX's recommended tag rotation program involving organophosphate tags. **Remove tags before slaughter.**



STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in a cool place in original container, away from direct sunlight. Opened bags containing ear tags should be resealed for storage.

PESTICIDE DISPOSAL: Remove tags before slaughter. Securely wrap used tags in a plastic bag or several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Non-refillable container. Do not reuse bag. Discard bag in trash or offer for recycling if available
