DANGER!

Do not get in eyes, on skin or on clothing.

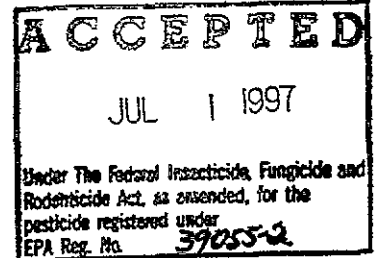
Wear goggles or face shield and rubber gloves when handling.

PHYSICAL AND CHEMICAL HAZARDS
COMBUSTIBLE LIQUID AND VAPOR

Flash Point - 155 to 180° F

Keep away from heat and flame. Avoid breathing vapor. Use adequate ventilation. Keep wetted materials well ventilated to prevent spontaneous combustion. Do not mix with strong oxidizers or corrosives. Keep container closed



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STORAGE DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

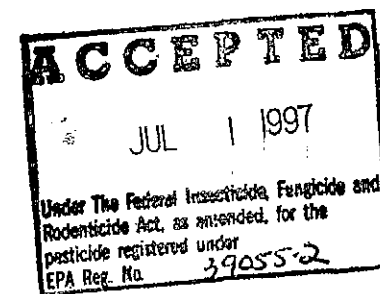
