

# INSTALLATION AND OPERATING INSTRUCTIONS

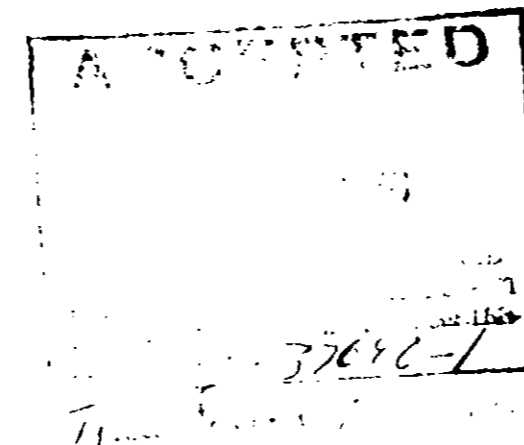
## GENERAL CLASSIFICATION

*It is a violation of Federal law to use this product in a manner inconsistent with its labeling.*

Your **Purity Bacteriostatic Water Treatment Unit** is fully charged with activated carbon and silver carbon to provide maximum efficiency of absorption as represented in our brochure.

Placement of unit under sink in rear is most desirable. The following steps must be followed for proper installation.

1. Make certain all fittings on unit are screwed tight to prevent leaking.
2. Locate pipe to be used for water source. Measure amount of 1/4" O.D. copper tubing required (available at most hardware stores).
3. Attach self tapping valve on water line (see attached instruction sheet).
4. Drill 1/2 inch hole in top sink at convenient place for use. If you want the hole drilled in enamel sink extreme care must be taken to prevent chipping of enamel. We suggest a piece of adhesive tape be placed on enamel where hole is to be drilled; a very small hole with a 1/16 drill should be first made then 1/8 drill; then 1/4 drill, lastly 1/2" drill, keeping tape secured during drilling. An escutcheon is provided to cover any small chipping which may occur. If possible, it will be found much easier to drill 1/2" hole beyond the enamel sink. No difficulty will be found in drilling a hole in stainless steel or vinyl tops.
5. With all connections properly made, follow instructions on tapping valve information sheet on starting water flow.
6. Turn on gooseneck faucet and allow water to run thru device for at least 20 minutes. Water will appear dark and cloudy at first but should completely clear up after the 20 minute period and be ready to produce clarified water.
7. An optional ice maker connection kit is available at a minimum charge. This kit furnishes a tee fitting that is attached to the outlet side of **Purity Bacteriostatic Water Treatment Unit**. This will connect unit with the line to the ice cube maker. The **Purity Bacteriostatic Water Treatment Unit** will deliver fine tasting water to both the gooseneck faucet and your ice cube maker.

Now you are ready to enjoy better tap water in the future for up to a 2500 gallonage volume dependent upon input water quality, amount of solids contained in the water source. When a reduction in the water flow is apparent, and a return of objectionable taste and odor occurs, or the gallonage limitation of the unit has been reached it is time for a replacement of the unit.

The replacement of **Purity Bacteriostatic Water Treatment Unit** is recommended at 2500 gallon usage. Replacement can be done by contacting your local factory representative or by shipping unit to factory.

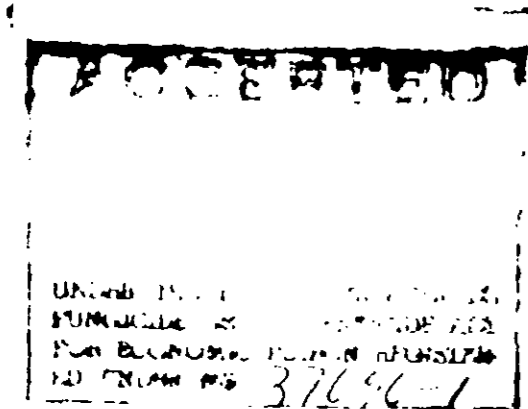
Unit may be removed by following these steps.

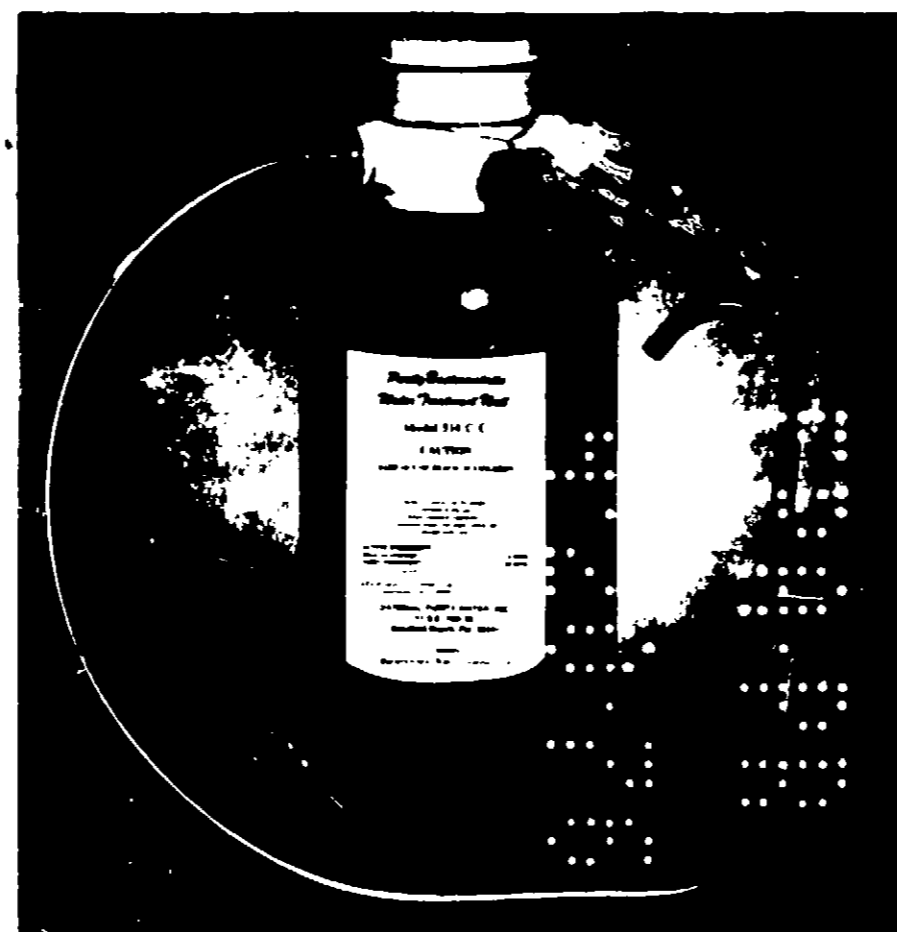

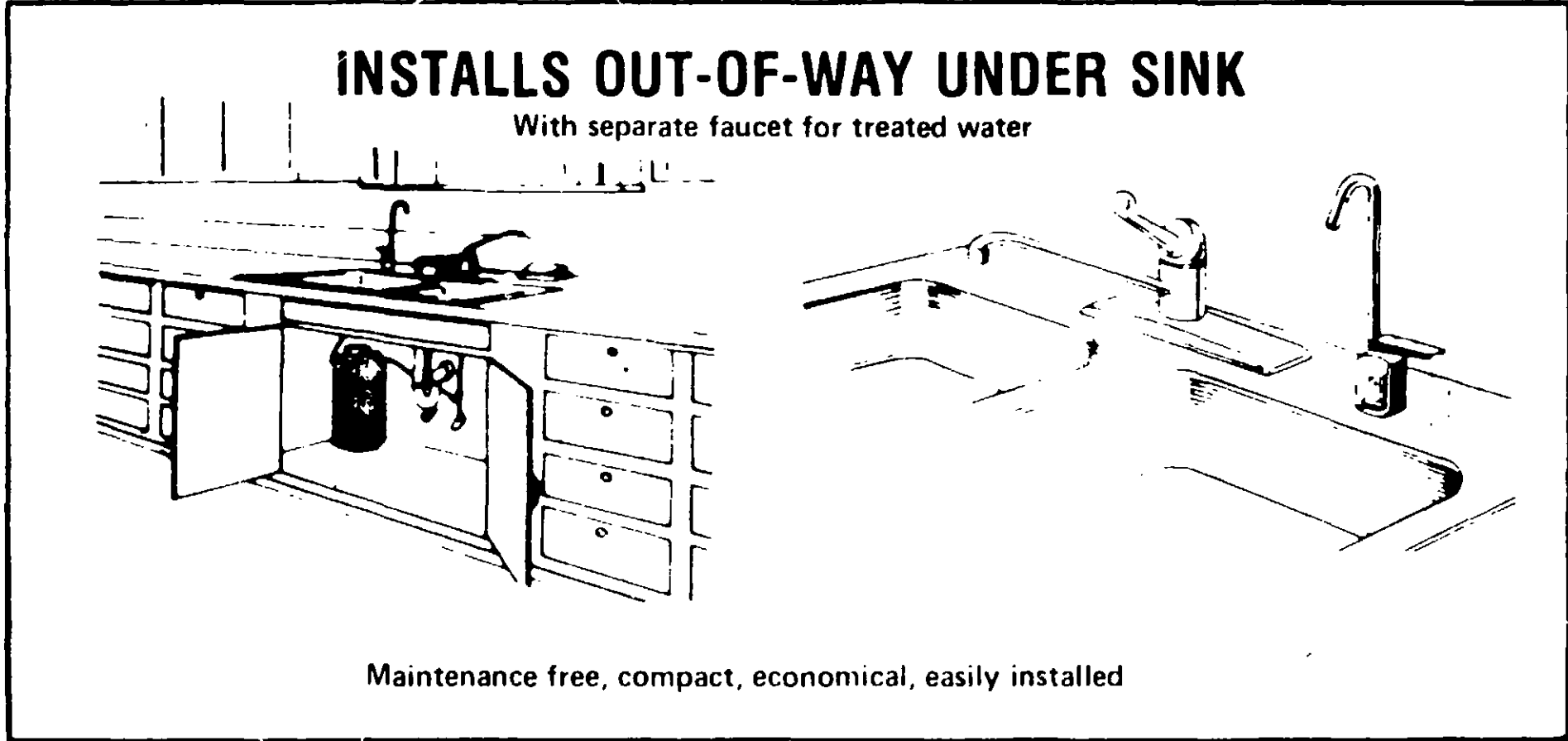

unit dimensions (minimum) ..... 12" high x 6" diameter  
flow rate ..... 1.0 gpm  
operating pressure ..... maximum 127.5 p.s.i.

operating temperature ..... 120 F  
bacteriostatic filtering material ..... approx. 5 lbs.
