DIRECTIONS FOR USE GENERAL CLASSIFICATION

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING

NOTE This product degrades with age. Use a chlorine test kit and increase dosage as necessary, to obtain the required level of available chlorine.

COMMERCIAL LAUNDRY BLEACH
Mix 1 gallon SODIUM HYPOCHLORITE SOLUTION to 14 gallons of water. Introduce this solution into your normal laundry process.

START OF SEASON OR FOR NEWLY FILLED SWIMMING POOLS
Add 10 oz. to 10,000 gallons of water (equivalent to 1.0 ppm available chlorine). Test with a reliable chlorine test kit and continue adding smaller amounts (10,000 gallons equivalent to 0.1 available chlorine) if necessary, until a residual of 0.6 to 1.0 PPM is established as determined by the test kit, and maintain at this level. Keep the pH at 7.2 to 7.6 at all times as determined by adequate pH test kit.

STORAGE AND DISPOSAL: Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container thoroughly with water and either return to manufacturer or discard by placing in trash collection or burying, in an approved landfill. Product or residue that cannot be used should be diluted with water and disposed of in sanitary sewer. Do not contaminate food or feed by storage, disposal or cleaning of equipment.
