PRODUCT INFORMATION

Sumithion 4-E/O is both a water emulsifier and oil dilutable concentrate containing 4 pounds of Sumithion per gallon. After dilution with either water or deoderized kerosene (or equivalent grade oil), it is intended for residual control in buildings and structures and in modes of transport. Permitted areas of use include, but are not limited to: Stores, warehouses, industrial buildings, houses, apartment buildings, and on vessels, aircraft, rail cars, buses, trucks and trailers.

The solvent used in this formulation is a petroleum distillate which may stain certain plastic, rubber, and asphalt materials. Before use test on an inconspicuous area of tiles, floor coverings and fabric. Care should be also taken to avoid spotting of wallpaper and fabric. Avoid spraying carpets with either oil or water dilutions as discoloration may result.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistant with its labeling.

To kill Cockroaches, Ant: Crickets, Silverfish, Spiders, Sowbugs, Flies, Fleas, Ticks and Mosquitoes:

For control of these pest, dilute Sumithion 4-E/O in either water or oil as shown below to make a 1.00% residual Spray.

Apply as a coarse low pressure spot spray, or apply with paint brush to areas where these pests hide, such as baseboards, all indoor storage areas, around water pipes, behind and under refrigerators, cabinets, sinks, and stoves, the underside of pallets, and similar areas where these insects hide or through which they may enter. Treated areas should be inspected 2 and 4 weeks after initial application.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and usually inside resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. Do Not Spray Pets With This Product.

Flies and Mosquitoes: Use out of doors and in and around buildings as an aid in reducing annoyance from these pests. Spray surfaces of windows, door frames and walls as well as other areas where these pests may congregate. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, garages and feedlots where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary. During spraying cover feed and water areas.
