On the basis of information furnished by the registrant, the above named pesticide is hereby Registered/Reregistered under the Federal Insecticide, Fungicide, and Rodenticide Act.

A copy of the labeling accepted in connection with this Registration/Reregistration is returned herewith.

Registration is in no way to be construed as an indorsement or approval of this product by this Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit/cite all data required for registration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling changes listed below before you release the product for shipment:

- a. Add the phrase "EPA Registration No.39444-9."
- b. Delete the statement, "In such cases, we reccommend use of Katadyn.....viral agent."
- c. Delete the term, "preservation" from the product labeling. This term implies that the product registered is a preservative for municipally treated water."

- d. Delete the statement, "Not for sale or use after (insert dated 10 years from the product labeling. The Agency has no data to substantiate that this product will maintain its efficacy claims for a period of 10 years. Additionally, the Agency has now determined that silver release data must be submitted to the Agency for our review to determine if the product will stay concentrated to continue its bacteriostatic action for any specified period of time. Please refer to the "Interim Requirements for Registration of Bacteriostatic Water Treatment Units for Home Use."
- e. Delete the term "General Classification" from the product labeling.

In order to remain in compliance with FIFRA, the following statement must appear in directions for use section of label on all end-use products for use for human drinking systems:

1. "Use with cold water only."
2. "The product is designed to remove objectional tastes, odors, and color from municipally treated tap water."
3. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
