

An initial slug addition of 5.1 to 10.2 fluid ounces of KEYSTONE MB-11 per 1000 gallons of water is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 1.7 to 10.2 fluid ounces of KEYSTONE MB-11 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the macropiological replace. Slug additions should be made in the sump of water cooling towers.
