

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

KEYSTONE MB-20 is used on recirculating cooling tower systems and industrial microbiological slime. Prior to the use of KEYSTONE MB-20 on recirculating cooling tower systems, clean the tower to remove algal growth, microbiological slime and other deposits. For initial slug addition of 5.7 to 8.6 fl. oz. of KEYSTONE MB-20 per 1000 gal. of water to provide 50 to 75 ppm KEYSTONE MB-20 based on total weight of water until control is evident. Make subsequent slug additions of KEYSTONE MB-20 (per 1000 gal. of water) every 2 to 3 days until control is evident. Slug additions should be made every 2 to 3 days until control is evident. KEYSTONE MB-20 is used on recirculating cooling tower systems which maintain effective mist-eliminating components. Clean the tower to remove bacterial slime and other deposits. For initial slug addition of 17.2 fl. oz. of KEYSTONE MB-20 per 1000 gal. of water to provide 10.0 to 17.2 fl. oz. of KEYSTONE MB-20 per 1000 gal. of water should be employed every 1 to 5 days until control is evident. Slug additions may be made to the sump or the tower system.

STORAGE AND DISPOSAL
