- Place the required number of generators evenly throughout the area of the greenhouse to be treated, positioned to allow uninhibited release. Place each generator on a 12 x 12 inch fireproof base. If multiple generators are to be used, prepare them all for ignition before lighting.
- 2. Tear off tag and remove container cap.
- 3. Light the igniter using a match. Light smoke generators in sequence, starting with generator furthest from the exit and move toward the exit. The smoke will begin to diffuse in 15 to 20 seconds.

- 4. Do not re-enter treated area during the REI of 12 hours unless wearing the PPE specified under the Agricultural Use Requirements section of this label.
- 5. After treatment is complete, open windows and doors and ventilate thoroughly.

STORAGE AND DISPOSAL
