This is in response to your proposed additional form (flowable) of the product. This amendment was submitted on July 27, 1992, and re-submitted with revised Confidential Statement of Formula on October 5, 1992.

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy of the labeling is enclosed for your records.

1. For our records, indicate the types of containers used for each form of the product.

2. Replace the old brand name ("49-155 ortho-Phenylphenol") with the new name "Preventol O extra." (This change is handwritten on the enclosed label copy.)

3. In the ingredients statement, change the "98%" to "99.9%", the nominal concentration indicated on your Confidential Statement of Formula. (This change is handwritten on the enclosed label copy.)

4. Submit five copies of the finished labeling before the product is released for shipment bearing the amended labeling.

Note that the Confidential Statement of Formula submitted with this amendment is not being accepted. However, it is
