
2. The Keep Out of the Reach Children's statement and the word Danger must be placed immediately following the ingredient statement.

## DANGER

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CORROSIVE:** CAUSES IRREVERSIBLE EYE DAMAGE OR SKIN BURNS. Harmful if absorbed through skin, swallowed or inhaled. Do not get in eyes, on skin or on clothing.
