Enclosed is a notification to update the label and label supplement for the above listed product. The changes are as follows:

LABEL

- Removed the exclamation point after the signal word under the PRECAUTIONARY STATEMENTS
- Added to the First Aid section "NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage." This statement is required for products which are corrosive (per the label review manual).
- Added "local" to sewage treatment under the ENVIRONMENTAL HAZARDS section.
- Added the registered trademark (®) and capitalized PREVENTOL each time it is used.

#### LABEL SUPPLEMENT

- Added "Recommended Dosages:" title under the following uses: Glues and Constant Adhesives, Materials in the Building Industry, Metal Working Fluids, Stains and Paints, Materials in the Textile Industry and Materials in the Paper Industry, Materials in the Oil Industry and Additional Materials.
- Under Materials in the Textile Industry the second reference to "Print Thickeners (liquid)" was removed as it was listed twice.
- Added the registered trademark (®) and capitalized PREVENTOL each time it is used.
