

Method of Addition

Aqueous Paints (including heating & air conditioning systems): Incorporate into the makeup water during the grind.

Latex Emulsions: Add using moderate agitation immediately following the cool-down of the emulsion and prior to entering the storage tank facilities.

Adhesives: Incorporate with agitation into the makeup water blend. However, where the adhesive is heated, Tektamer 38 A.D. should be added during the cool-down cycle.

Dispersed Pigments: Add using moderate agliation immediately following the cool down of the dispersed pigment and prior to entering the storage tank facilities.

Joint cements: Incorporate with agitation into the makeup water blend. Metalworking Fluids: Add to the final diluted cutting fluid, either prior to its addition to the system, or after the system has been filled.

Tektamer 38 A.D. should be thoroughly mixed into the system to assure efficacy. If Tektamer 38 A.D. is added to the concentrate, testing should be done to assure compatibility.

Waxes, Polishes and Inks: Incorporate into the makeup water blend with moderate agit AGCEPTED
