

Submissions dated February 29, 2008 and April 21, 2008

The amendment referred to above, submitted in connection with registration under Section (3)(c)(7) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable as follows:

1. The basic Confidential Statement of Formula dated January 16, 2008 is acceptable and supersedes all previous CSFs becoming the CSF of record.
2. The submitted Group A product chemistry data are acceptable. The Group B product chemistry data cited from previous submissions are also acceptable.
3. Product chemistry data requirements for the same product after relocating the plant in the USA have been discussed in the data evaluation review (DER). Please refer to it for more information.
