Sweep up and remove to chemical waste area for your disposal. Concentrate is stable at normal storage temperatures.

FIRST AID

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Preventol HS 100 - CS 50 is a concentrated suspension insecticide containing 4.75% by weight active ingredient which will provide residual protection of wood from termite attack. Dilute Preventol HS 100 - CS 50 in water to produce a 0.0005% to 0.1% solution, depending on expected solution uptake into the wood. Treatment conditions and uptake should produce a 0.0004 to 0.0008 pounds/cubic foot (pcf) retention in the treated wood. This formulation is to be used for application methods given below. Wood treated with this product is only for above ground uses that are continually protected from direct exposure to the weather.

APPLICATION BY BRUSH OR SPRAYING: Wood should be clean, dry and free of bark. Apply two coats liberally by brush, roller or spray to point of runoff. Allow at least one hour between coats. Allow wood to re-dry prior to application.

TANK MIX RECOMMENDATIONS: Preventol HS 100 - CS 50 can be tank-mixed with other pest control products labeled for wood treatment. When tank-mixing, observe all restrictions and precautions and limitations which appear on the label of each product. For any tank-mixture which has not been previously tested, mix the correct proportion of products and water in a quart jar to ensure proper physical compatibility of the mixture.

¹The purpose of such applications of Preventol HS 100 - CS 50 is to kill workers or winged forms which may be present at the time of treatment and to impart a temporary resistance at these places from attack which may aid in the prevention of immediate reinfestation.
