The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. The Agency approves: the addition of stable flies, black flies and ticks; removal of fleas; and an increase in the protection times for mosquitoes and ticks to 12 hours based on recently accepted studies that were reviewed by OPP and HSRB.




