# PRECAUTIONARY STATEMENTS

## HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Causes moderate eye irritation. Harmful if swallowed. Avoid contact with eyes skin or clothing. Wear protective eyewear (goggles or face shield). Wear long sleeve shirt, long pants or overalls and rubber or neoprene gloves. Use a cartridge respirator if the area is not well ventilated and during clean-up, maintenance and repair activities. Have the product container or label with you when calling a poison control center or doctor or going for treatment.

Note to Physician: No specific antidote. Treat symptomatically. The compound does not cause any definite symptoms that would be diagnostic. Poisoning may be accompanied by hyperactivity followed by sedation.

### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Formulators are responsible for obtaining their own EPA Registration No. and developing the data required to support their registrations. PREVENTOL® A 20 is intended for use in the formulation of fungicides in aqueous and solvent systems to protect wood composite products and wood products intended for above ground and in-ground contact. Wood treated with PREVENTOL® A 20 must not be used in aquatic applications such as dock pilings.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

RESTRICTIONS: Do not package Preventol A20 in metal containers.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. Completely empty bag into application equipment by shaking and tapping sides and bottom to loosen clinging particles.
