

Please find enclosed a notification to update the label for the Lanxess product Preventol S600-L (EPA Reg # 39967-73). This is a notification to update the label to match the Label Review Manual. Specifically, the font for the signal word was changed to font size 18, the font for the KOOROC was changed to font size 12, and the Storage and Disposal heading was changed to font size 12. Also, the words "manufactured for" were removed from the label since this is not a supplemental, the exclamation point was removed from the signal word, the signal word was placed below the KOOROC and the Emergency number information was formatted to match our other labels.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. POST PROCESS APPLICATION FOR LEATHER

Prior to shipping the stack of hides should be sprayed with a solution of Preventol S600-L to prevent the formation of mold. The product should be applied via a garden sprayer and applied at a distance of 24 to 36 inches from the contact point. Wrap the stack of hides in plastic prior to storage to prevent drying out. Preventol S600-L should be diluted to the following solution strength prior to use:

Mixture Proportions: (parts by wt) 600 ppm of Active Ingredient

Preventol S600-L 190 ml Water 810 ml

Or Mix 1 gallon of Preventol S600-L with 4.3 gallons of water.

ENVIRONMENTAL FUNGAL CONTROL

Apply Preventol S600-L for general control of mold spores in tannery environment to include exposed wood, concrete floors and walls. Use a garden sprayer positioned 24 to 36 inches from the desired contact point. The Preventol S600-L should be diluted to the following strength prior to use:

Mixture Proportions: (parts by wt) <450 ppm of Active Ingredient

Preventol S600-L 166 ml
Water 834 ml
Or Mix 1 gallon of Preventol S600-L with 5 gallons of water.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to the label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.
