The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false

DIRECTIONS FOR USE

Biochek® 8069 is a liquid formulation containing Thiabendazole and Propiconazole specifically designed to protect flexible PVC systems, e.g. vinyl flooring, gaskets, tarpaulins, pool and pond liners, PVC plastisol coated textiles etc. against the growth of mold and mildew organisms. It may also be used as a preservative in other polymeric products, e.g. polyurethanes, silicones and polyether silicones.

The required dose level of Biochek® 8069 based on the total weight of the final treated product is in the range of 0.2% -3.0% and depends on the environment the treated article is used.

Biochek® 8068 must not be used on items which come into contact with food stuffs, medical devices, or children's products such as toys or clothing.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Keep container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER HANDLING: Metal or plastic containers: Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available or reconditioning if appropriate.
