

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS
AND DOMESTIC ANIMALS**

CAUTION

Harmful if swallowed. Avoid breathing spray mist. Avoid contact with skin, eyes or clothing. In case of eye contact, immediately flush with plenty of water. Get medical attention if irritation persists. Remove and wash contaminated clothing before reuse. Wash thoroughly after handling.

ENVIRONMENTAL HAZARDS

Keep out of lakes, ponds or streams. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not let the liquid come in contact with susceptible plants, such as vegetables, flowers, fruit trees, ornamentals, cotton, grasses, or other desirable plants or allow spray mists to drift onto these plants. (Coarse sprays are less likely to drift.) Thoroughly clean spray equipment before using for other purposes. Do not apply to areas underlain by roots of desirable trees and shrubs.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

General Weed Control--Weed Killer Concentrate can be used to control most weeds for an extended period of time on non-cropland areas such as loading ramps, fence rows, railroad sidings, storage yards, parking lots, around buildings and industrial plant sites.

To control annual weeds and grasses such as foxtail, ryegrass, wildoats, crabgrass, cheatgrass, broomsedge, ragweeds, lambsquarter and turkey mullein, dilute one gallon of concentrate to 9 gallons of water and apply 5 gallons of the diluted spray, per 1,000 square feet.

For hard to kill perennial weeds and grasses such as johnson grass, salt grass, bouncing bet, bracken fern, horsetail, smooth broome, canada bluegrass, purple-top quackgrass, broomsedge, aster dandelion, dog fennel, goldenrod, plantain and wildcarrot, dilute one gallon of concentrate to 9 gallons of water and apply 10 gallons of diluted spray per 1,000 square feet.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Pesticide, spray mixture or rinsate that cannot be used or chemically processed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Container should be resealed and offered for reconditioning or triple rinsed and disposed of in an approved landfill or buried in a safe place.
