

**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION**

Harmful if swallowed. May be absorbed through skin. Avoid inhalation of spray mist. Avoid contact with skin, eyes or clothing. Wash thoroughly after handling and before smoking or eating. Avoid contamination of feed or foodstuffs. Remove pets and cover fish tanks before spraying. Do not use on household pets or humans. Do not allow children or pets to contact treated areas until surfaces are dry.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**FOOD HANDLING ESTABLISHMENTS** - Places other than private residences in which exposed food is held, processed, prepared or served.

**FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY** Includes areas for receiving, storage packing (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) and serving areas (when food is exposed and facility is in operation).

To control roaches, ants, waterbugs, silverfish, spiders and crickets apply in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream of insecticide in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, in conduits, motor housings, junction or switch boxes. Prior to application de-energize electrical equipment. After application allow time for oil to evaporate before starting motors or placing switches in "ON" position. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

**APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.**

**SERVING AREAS** - Facilities where foods are served such as dining rooms, but excluding areas where foods may be prepared or held. Apply as a spot treatment to selective surfaces such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation if foods are exposed.)

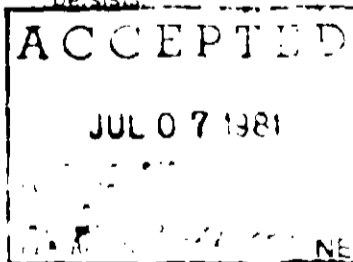

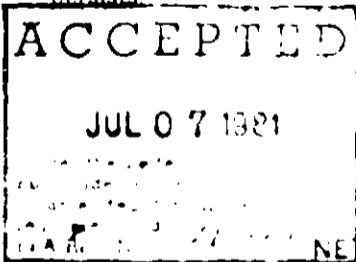

**NON-FOOD AREAS:** Including garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling). Apply to baseboard areas, around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where insects hide or through which they may enter. Repeat treatment as required.

**CARPET BEETLES:** Spray edges of carpeting and under carpeting and rugs. Make localized application to the floor and baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat as necessary.

**BROWN DOG TICKS:** Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows, door frames and wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. **DO NOT TREAT ANIMALS WITH THIS FORMULATION.**

**FLIES, MOSQUITOES, WASPS AND SMALL FLYING MOTHS - OUTDOORS:** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors and window frames or wherever these pests may enter the room. Also treat surfaces around light fixtures on porches, in garages where these insects may alight or congregate.

**FLEAS, CHIGGERS, ANTS - OUTDOORS:** For treatment of localized infestations of these insects in outdoor areas, spray weeds and bushy non-crop areas around the home thoroughly. Avoid spraying desirable plants. For ants, thoroughly wet nests and runways. Repeat applications as infestations warrant and as reinfestation occurs.

**FOR SPOT APPLICATION ONLY. DO NOT USE AS A SPACE SPRAY.**

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **PESTICIDE DISPOSAL:** Pesticide spray mixture or residue that cannot be used according to label instructions must be disposed of according to Federal, State or local procedures under the Resource Conservation and Recovery Act.
