GENERAL CLASSIFICATION

FEEDING DIRECTIONS

Gossett SOW PRE-MIX No. 35 is designed specifically for fortifying modern-day confinement corn-soybean rations for lactating swine breeding stock. Add sixty (60) lbs. per ton of complete ration.

MIXING DIRECTIONS

<u>Ingredients</u>	<u>lb/ton</u>
Ground Shelled Corn - - - - -	1,500
44% Soybean Meal - - - - -	350
Gossett SOW PRE-MIX No. 35 - - - - -	60
Salt, Plain - - - - -	10

Offer the above ration free-choice. This is equivalent to 22.7 mg. of RABON per lb. of feed.

Sow Pre-Mix No. 35 may be fed up to slaughter.

Sow Pre-Mix No. 35 prevents the development of house flies in the manure of treated sows but is not effective against existing adult flies. When starting a feeding program during the fly season, it may be necessary to use other control measures to reduce the population of existing adult flies.

Supplemental fly control measures may be needed in and around hog lots and buildings to control adult house flies and stable flies which can breed not only in hog manure but in other decaying vegetable matter or silage on the premises.

In order to achieve optimum fly control, Sow Pre-Mix No. 35 should be used in conjunction with other good management and sanitation practices.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Disposal: Pesticide that cannot be used according to label instructions must be disposed of according to applicable Federal, State, or Local procedures.
