in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 2.0

VWT 340 per 1000 gallons

is recommended. Repeat initial dosage until control is achieved.

Subsequent slug additions of 0.85

VWT 340 per 1000 gallons

every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in original container. Do not store in damaged drums should be placed in overpack. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
