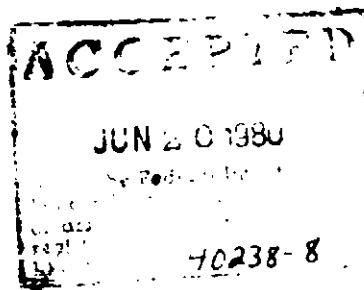

DIRECTIONS FOR USE

WARNING
