

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

Tower Treat B 208
in recirculating commercial and industrial water systems must be cleaned to remove algal and other deposits. An initial slug addition of Tower Treat B 208 per gallon is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 2.3 Tower Treat B 208 per 1000 gallons should be made every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in original container. Do not store in damaged drums. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpack and should not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
