DIRECTIONS FOR USE

Rates given are to be mixed with 100 gallons of water. Contact your Cooperative Agricultural Extension Service for timing of application. Not for use in control of Phosphate resistant Red Spider Mites or Pear Psylla.

APPLES
 Aphids: 2-2½ lbs. Make 1 or more applications as needed.
 Red Spider Mites: 2-2½ lbs. Make at least 2 applications 10-12 days apart during the summer months. **NOTE:** Do not apply within 3 days of harvest. Malathion may injure McIntosh and Cortland Varieties.

PEARS
 Red Spider Mites: 2-2½ lbs. Make 2 applications 10-12 days apart when infestations warrant. Pear Psylla: 2-2½ lbs. Apply 1 or more sprays as needed for control. **NOTE:** Do not apply within 1 day of harvest.

CABBAGE, BROCCOLI, KALE, MUSTARD, TURNIPS
 Aphids, Imported Cabbageworms, Cabbage Loopers: 2 lbs. Make full coverage application and repeat as needed for control. **NOTE:** Do not apply within 7 days of harvest on cabbage, kale, and mustard; 3 days for broccoli and turnips.

POTATOES
 Aphids, Leafhoppers: 2½ lbs. Make 1 or more applications as needed for control.

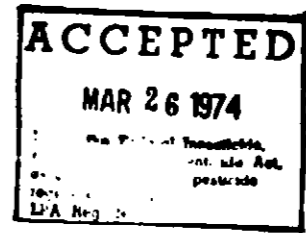
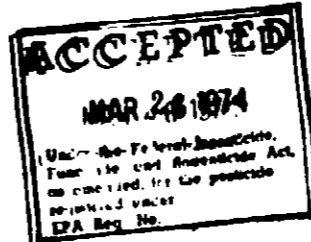
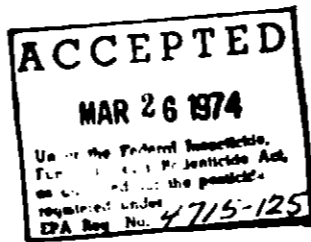
TOMATOES
 Aphids: 2 lbs. Make 1 or more applications as needed. Spider Mites: 2 lb. Apply as needed. **NOTE:** Do not apply within one day of harvest.

ORNAMENTALS
 Lace Bugs, Bagworms: 4 lbs. Tent Caterpillars: 2 lbs.
 Aphids, Mealybugs, Spider Mites, Whiteflies: 2½ lbs. This spray will also control the Leafhopper and Thrips that may be present. Soft Brown Scale, Juniper Scale: 6 lbs. Make a thorough application and repeat as necessary. For Scale: Spray after the crawlers have settled on the foliage. **NOTE:** Injury may result to certain ferns and some species of Crassula as well as Canasert Junipers.

BEEF CALFLE
 Lice: 16 lbs. One treatment may be sufficient. Repeat only if needed for control. Horn Fly: 16-24 lbs. Apply a complete coverage spray. Repeat application at 2-week intervals, if needed. **NOTE:** Do not apply to dairy animals. Do not treat calves under one-month of age. Avoid contamination of feed, food, food containers and water troughs.
