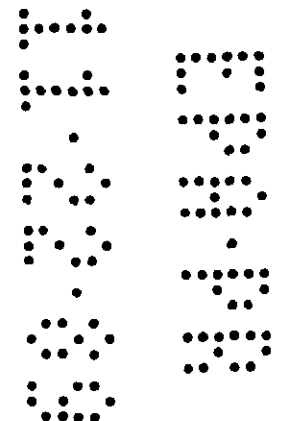

SHAKE BEFORE USE. HOLD CAN UPRIGHT. APPLY IN SHORT BURSTS.

INDOORS: To Kill Flies, Mosquitoes, Small Flying Moths, Gnats and Wasps: Close all doors and windows and direct spray upward into center of room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

To Kill Ornamental Plant Pests such as Aphids, Leafhoppers, Lacebugs, Whiteflies, Spiders, Mites, Japanese Beetles, Mealy Bugs, Caterpillars, Box Elder Bugs, & Eastern Tent Caterpillars: General: When sprayed directly in insects, this spray will kill the insects listed. Caution should be taken when spraying new tender growth on young plants.

WHEN SPRAYING, HOLD CAN 18-24 INCHES FROM PLANT.

For best results, spray in the evening or on a cloudy day when air is still. Mist the plants lightly. Use a slow sweeping motion. Avoid wetting foliage with spray. Spray

rows at the rate of 1 foot per second. For heavy growth, spray both sides of row. Repeat as needed. Do not spray when temperatures exceed 90 F.

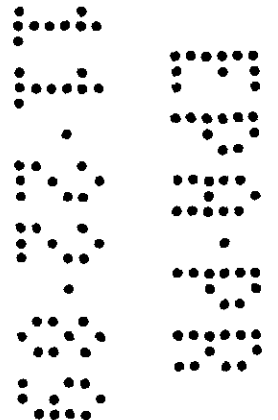
Storage: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat, open flame or other sources of ignition. Disposal: Replace cap, wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture.
