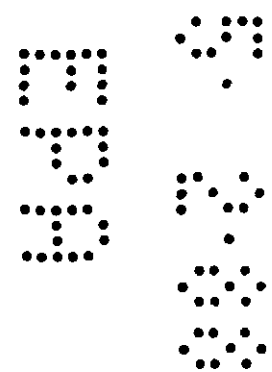

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors. Avoid contact with skin or clothing. Do not use in commercial food processing storage, preparation or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed with a suitable cleaning compound followed by a potable water rinse before use. Cover exposed food. Remove pets, birds and cover fish aquaria before spraying.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Immediately contact a physician or poison control center. Do not induce vomiting due to aspiration hazard. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated. Contact a physician if warranted. **If On Skin:** Immediately remove contaminated clothing and wash skin with plenty of water. Contact a physician if irritation persists. Wash clothing prior to reuse.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near fire, sparks or heated surfaces. Do not smoke while using this product. Do not puncture or incinerate container. Exposure to temperatures above 130 F may cause bursting. Incineration of container may cause explosion.

ENVIRONMENTAL HAZARDS

Do not apply directly to water or wetlands (swamps, bogs, marshes and potholes). Cleaning of equipment or disposal of wastes must be done in a manner that avoids contamination of bodies of water or wetlands.

SHAKE BEFORE USE. HOLD CAN UPRIGHT. APPLY IN SHORT BURSTS.

INDOORS: To Kill Flies, Mosquitoes, Small Flying Moths, Gnats and Wasps: Close all doors and windows and direct spray upward into center of room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

To Kill Ornamental Plant Pests such as Aphids, Leafhoppers, Lacebugs, Whiteflies, Spiders, Mites, Japanese Beetles, Mealy Bugs, Caterpillars, Box Elder Bugs & Eastern Tent Caterpillars: General: When sprayed directly in insects, this spray will kill the insects listed. Caution should be taken when spraying new tender growth on young plants.

WHEN SPRAYING, HOLD CAN 18-24 INCHES FROM PLANT.
