PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors. Avoid contact with eyes, skin or clothing. Do not use in commercial food processing, storage, preparation or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food. Remove pet, birds, and cover fish aquariums before spraying. DO NOT USE IN OR AROUND ELECTRICAL EQUIPMENT DUE TO THE POSSIBILITY OF SHOCK HAZARD.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Immediately contact a physician or poison control center. Do not induce vomiting due to aspiration hazard. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated. Contact a physician if warranted. **If On Skin:** Immediately remove contaminated clothing and wash skin with plenty of water. Contact a physician if irritation persists. **Wash clothing prior to reuse.** **If In Eyes:** Immediately flush with plenty of water. Contact a physician if irritation persists.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 100°F may cause bursting. Incineration of container may cause explosion.

ENVIRONMENTAL HAZARDS

Do not apply directly to water or wetlands (swamps, bays, marshes and bays). Cleaning of equipment or disposal of wastes must be done in a manner that avoids contamination of bodies of water or wetlands.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **Storage:** Store in a cool, dry place, preferably locked, inaccessible to children and pets and away from heat, open flame or other sources of ignition. **Disposal:** Replace cap, wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture.

SHAKE BEFORE USE. HOLD CAN UPRIGHT. APPLY IN SHORT BURSTS.

INDOORS: To Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close all doors and windows and direct spray towards center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

To Kill Ornamental Plant Pests such as Aphids, Leafhoppers, Lacebugs, Whiteflies, Spiders, Mites, Japanese Beetles, Army Bugs, Caterpillars, Box Elder Bugs & Eastern Tent Caterpillars: General: When sprayed directly on insects, this spray will kill the insects listed. Caution should be taken when spraying new tender growth on young plants.

WHEN SPRAYING, HOLD CAN 18-24 INCHES FROM PLANT.

For best results, spray in the evening or on a cloudy day when air is still. Mist the plants lightly. Use a slow sweeping motion. Avoid waiting forage with spray. Spray slowly at the rate of 1 foot per second. For heavy infestations, spray both sides of row. Repeat as needed. Do not spray when temperatures exceed 90°F. **Labeling:** Rotating, Covering, Blanketing Foam.

DO NOT SHAKE BEFORE USING. HOLD CAN UPRIGHT. APPLY IN SHORT BURSTS.

OUTDOORS: To Kill Wasps: Application should be made at dusk or early morning when insects are least active. Hold can upright. Point valve covering away from face. With wind at back, aim at nests in trees, bushes, under eaves, downspouts, cracks or crevices.

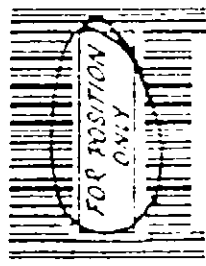
To Kill Yellow Jackets: Yellow Jackets make their nests in the ground, dead tree stumps, railroad ties, walls or similar structures. During daylight hours watch them closely to determine location of nest entrance. Wait until dusk or early morning when insects are at rest. Empty aircan down hole from a close enough distance to direct 100% of spray into hole.

To Kill Hornets: Unless you can clearly see the opening at the bottom of the hornets nest, never use a hornet spray (on the nest) as hornets may escape and attack you. Hornets usually make their nests in trees, shrubs and under eaves. During daylight hours, determine location of nest entrance. Wait until dusk or early morning when insects are at rest. Direct beam spray into entrance hole. As hornets fall out continue spraying until no more are visible or the can is empty. Leave area immediately. When used to kill wasps, hornets and/or yellow jackets do not use inside the home.
