Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on nonrefillable containers. Wet the pet's coat with warm water. Do not apply shampoo around eyes. Apply shampoo on head and ears, then lather; repeat procedure with neck, chest, middle and hindquarters, finishing legs last. Let animal stand three to five minutes (this is an important part of the grooming procedure) then thoroughly rinse animal. Dry with a towel or immediately repeat treatment on extremely dirty or scaly animals; otherwise do not reapply for 7 days. The pet will have a clean, lustrous coat, free of fleas and ticks. . Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant or nursing animals. Simultaneously treat pet bedding and quarters with a product approved for premise treatment.
