

**RATS & MICE:** Replace contaminated or spoiled bait immediately.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with the labeling.

**USE RESTRICTIONS:**

For control of Norway rats, Roof rats and House mice in and around homes, industrial, commercial, agricultural buildings, and any similar manmade structure, may also be used inside transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. Treated baits must be placed in locations not accessible to children, pets, domestic animals, wildlife or in tamper proof bait stations. Do not place baits in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

**SELECTION OF TREATMENT AREAS:**

Determine area where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls or in locations where rodents or their signs have been observed. Remove as much food as possible.

**APPLICATION DIRECTIONS**

**RATS:** Apply 3 to 15 ounces of bait (usually at intervals of 15 to 30 feet) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.


**HOUSE MICE:** Apply ¼ to ½ ounce of bait at intervals of 8 to 12 feet per placement. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Maintain uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.
