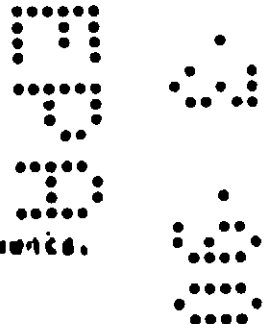

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**HOLD UPSIDE-DOWN TO SPRAY  
TO KILL FLEAS**

**To Treat Pets' Quarters:** Remove and destroy old pet bedding. Spray sleeping quarters of pets, around baseboards, windows and door frames, wall cracks and floors. Repeat as necessary. Do not spray animals. Put fresh bedding in pet's quarters after spray has dried. Treat dogs and cats with an ENFORCER flea and tick control product registered for use on pets before allowing them to enter treated area.

**To Treat Carpets:** Move furniture away from wall. Spray at the rate of 3 square ft. per second. Allow carpet to dry. Replace furniture and spray balance of carpeting. Repeat treatment as necessary.

**NOTE:** Avoid walking on carpet until dry due to the slippery nature of this product. Do not spray on linoleum or other hard surfaces where slipping may occur.

**To Treat Furniture:** Remove covers, cushions and pillows. Test spray in a small inconspicuous area and allow to dry. Make sure this product is compatible with fabric before using. Spray at the rate of 3 square feet per second. Do not permit humans or pets to contact treated surfaces until the spray has dried.

**Storage:** Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat, open flame or other sources of ignition.

**Disposal:** Replace cap, wrap container in several layers of newspaper and discard in trash collection. Do not incinerate or puncture.

**PRECAUTIONARY STATEMENTS**

**Hazards to Humans & Domestic Animals**

**CAUTION:** Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors. Causes moderate eye irritation. Avoid contact with skin eyes or clothing. Wash thoroughly with soap and warm water after handling.

Do not use in commercial food processing or preparation areas. In the home, all food processing surfaces or utensils should be covered during treatment, or thoroughly washed before use. Cover exposed food.

Remove pets, birds and cover fish aquaria before spraying.

**STATEMENT OF PRACTICAL TREATMENT**

**If Swallowed:** Do not induce vomiting due to aspiration hazard. Contact a physician or Poison Control Center immediately.

**If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated. Contact a physician if necessary.

**If On Skin:** Immediately remove contaminated clothing. Wash affected area of skin with soap and warm water. Contact a physician if irritation persists. Wash clothing prior to reuse.

**If In Eyes:** Immediately flush eyes with plenty of water. Contact a physician if irritation persists.

**NOTE TO PHYSICIAN:** Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is antidotal.
