DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Shake Well

Do not use in commercial food processing, preparation, storage or serving areas. In the home when used indoors, remove all exposed food and cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops. Remove pets, birds and cover fish aquariums before spraying. Do not allow children or pets to contact treated surfaces until spray has dried. Provide adequate ventilation of area being treated.

Do not apply in classrooms when in use. Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm. Do not apply to institutions (including libraries, sports facilities, etc.) in the immediate area when occupants are present.

For Spot Treatment

To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, Earwigs and Carpet Beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; crack and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets; and around garbage cans, plumbing and other utility installations. Directly spray pests driven out of hiding places. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested area such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards; window and door frames and localized areas of floor and floor coverings where these pests may be present. Remove old bedding and replace with clean, fresh bedding after treatment. Do not spray pets with this product. Simultaneously treat pets with a product registered for flea and tick control on pets in conjunction with this treatment. Also, treat your yard with a product registered for yard application.

For Crack and Crevice

To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas, Earwigs and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices. Use equipment capable of delivering a pin stream in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where the above-listed insects hide. Avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

Flies and Mosquitoes: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and doorframes as well as other areas where these pests may enter the home [building]. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Remove all exposed food and cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops. Hold can 2 to 3 feet from surface to be treated and spray in infested surface of patio or picnic area, hitting as many insects as possible. Spray to slightly moisten the surface.
