Do Not Use This Product on Cats or Kittens!

HOLD CONTAINER UPRIGHT + SHAKE WELL BEFORE USING

This product will kill fleas up to 14 days and ticks up to 7 days on dogs.

DOGS: Spray the animal from a distance of 8 - 12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Do not spray in face, eyes or on genitalia. Do not reapply product for 7 days. Apply at the rate of 2 seconds per pound of body weight for thin or short-haired dogs and up to 4 seconds per pound of body weight for heavy or long-haired dogs.

PUPPIES: Spray only on back and rub in with finger tips. Do not treat nursing puppies. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication.

PET SLEEPING QUARTERS: Remove old pet bedding and wash thoroughly. Thoroughly spray area and replace with new bedding which has been sprayed. Make sure spray has dried before allowing pets to reoccupy the area.

STORAGE: Store in original container in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat and sunlight. Protect from freezing (32°F/0°C).

DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and dispose in trash.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if inhaled. Avoid breathing vapors. Avoid contact with skin or clothing. Do not use on puppies under 12 weeks of age.
