Put out all flames and pilot lights. Do not use this unit in a cabinet or under a counter or table. Do not use this unit in an area less than 100 cubic feet. Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 5,000 cubic feet of unobstructed area. Prior to re-entry, treat dogs and cats with a flea and tick control product registered for use on pets. Also, to minimize reinfestation, treat outside areas with a product registered for controlling fleas and ticks around the home and yard.
