It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product kills Cockroaches, Houseflies, Confused Flour Beetles, Saw-toothed Grain Beetles, Rice Weevils, Small Flying Moths, Fleas, Ticks, Pill bugs and Crickets.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 5,000 cubic feet of unobstructed area. Do not remain in the area during treatment and thoroughly ventilate before re-entry.

**Do not** use more than one fogger per room. **Do not** use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller; instead, allow fog to enter from other rooms. Turn off **all** ignition sources such as pilot lights (shut off gas valves), other open flames, or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights.

**To Operate Valve:** Place several layers of newspaper or a pad on a stand or table in the center of the room. Be sure to cover entire surface of stand or table to prevent damage. Point valve opening away from face and eyes when releasing. For automatic discharge, lock valve in open position by pressing valve button all the way down, hooking the catch. Then place fogger on stand or table (in center of room) with valve locked open. Leave building at once and keep building closed for four hours before airing out. To air out, open all doors and windows and allow to air for 30 minutes before reoccupying. Repeat treatment in two weeks or when necessary.

**To Kill Ticks and Fleas:** Destroy and replace pet's old bedding. Use product as above. Do not use this product on pets. Prior to re-entry, treat pets with an Enforcer flea and tick control product registered for use on pets. Repeat as necessary to bring infestation under control.

Foggers alone will not control fleas and ticks. To control fleas and ticks, simultaneously treat the pet and its inside and outside living areas. [To effectively control fleas and ticks, simultaneously treat your pet, home and yard.] If you treat only your home (or only your pet) the treatment will not be effective and the fleas and ticks will return. To kill flea eggs, use a registered Enforcer product containing an insect growth regulator.

**STORAGE AND DISPOSAL**

**Storage:** Store in a cool, dry (preferably locked) storage area inaccessible to children and pets and away from heat, sparks, flames and other sources of ignition. **Disposal:** Do not incinerate or puncture! **If Empty:** Place in trash or offer for recycling if available. **If Partly Filled:** Call your local solid waste agency or 1-800-Cleanup for disposal instructions.
