DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE

GENERAL: Use this residual spray as a spot or crack and crevice treatment to control cockroaches, waterbugs, silver-fish, ticks, fleas and other insects listed below. Apply this product as a coarse spray to Localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed. For application only. Do not use as a space spray.

FOR SPOT/CRACK/CREVICE TREATMENT

To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Soubugs, Carpet Beetles, Scorpions and Black Widow Spiders: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Posts driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

To <u>Kill Brown Dog Ticks</u> and <u>Fleas</u>: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests mey be present. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Pets should be treated simultaneously with a flea and tick product registered for use on pets before re-entering area.

To Kill Ants, Cockroaches, Crickets, Silverfish, Soubugs, Spiders, Earwigs, Brown Dog Ticks, Fleas, Carpet Beetles, Dermestids, Scorpions and Black Widow Spiders: Apply spray in small amounts directly into cracks and crevices. A stream-like spray should be used in points between different elements of construction, between appliances and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where the above listed insects hide.

Care should be taken to avoid introducing the material into the air. Avoid contamination of food or food processing surfaces.

OUT OF DOORS

<u>Flies</u> and <u>Mosquitoes</u>: Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting places (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment as necessary.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat or open flame. DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.
