Cover exposed food, dishes, and food contact surfaces. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill Black Carpet Beetles, Centipedes, Cockroaches, Crickets, Fleas, Houseflies, Mosquitoes, Pill Bugs, Rice Weevils, Saw-tooth Grain Beetles, Silverfish, Small Flying Moths, Spiders, Ticks and Wasps.

Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 5,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: Place several layers of newspaper or a pad on a stand or table in the center of the room. For automatic discharge, lock valve in open position by pressing valve button all the way down, hooking the catch. Then place fogger on stand or table (in center of room) with valve locked open. Leave building at once and keep building closed for four hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat treatment in two weeks or when necessary.

TO KILL TICKS and FLEAS: Destroy pet's old bedding and replace. Use product as above. Treat dogs and cats with an ENFORCER flea & tick control product registered for use on pets prior to re-entry. Repeat as necessary to bring infestation under control.

Foggers alone will not control fleas. To control fleas, treat the pet and its inside and outside living areas at the same time. If you treat only your home (or only your pet) the treatment will not be effective, and the fleas will return. To effectively control the fleas, you must treat your pet, home and yard.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat, sparks, flames and other sources of ignition.

DISPOSAL: Replace cap, wrap container in several layers of newspaper and dispose in trash. Do not incinerate or puncture.

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: May be harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Wash with soap and water after use. Avoid contamination of food or feedstuffs. Do not use in commercial food processing or preparation areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food. Remove pets, birds and cover fish aquariums before spraying.
