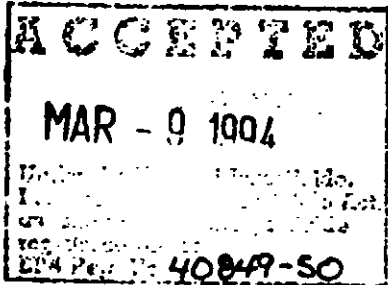

Enforcer DOT Flea Killer for Carpets is a quick-acting flea and tick killing deodorizer. At the same time, it overcomes household odors, leaving a clean, fresh smell.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**DIRECTIONS:** Shake well before using as some settling may occur during shipment.

**CARPETS:** Apply only to dry carpet, where pets frequently traffic or sleep, at the rate of one pound per 100 square feet (31.5 mg./sq.in.). In other and adjacent areas, apply at the rate of one pound per 200 square feet (16 mg./sq.in.). Work this product well into the base of the carpet pile with a broom, rug or other approved grooming equipment. Any visible product remaining after application must be removed by further grooming or by vacuuming. Allow three to five weeks for maximum flea control and reapply as needed. **Note:** If high adult flea populations make it necessary, apply an approved pesticide, designed to kill adult fleas, before or in conjunction with this product.

**UPHOLSTERY:** Remove loose cushions. Apply product with an approved applicator along creases and into corners and furniture wells. Do not apply to exposed fabric. Any visible product remaining after application must be removed.

**STORAGE:** Store in a cool, dry place. **DISPOSAL:** Do not reuse empty container. Wrap and put in trash.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

The following information will assist in the effort to control flea infestations:

When trying to eradicate infestations, vacuuming everyday is important. Fleas are in a pupate stage for approximately 2 to 3 weeks before being mature enough to emerge as adults. In the pupate stage, the flea is untouched by bombs, sprays or powder. During these first 2 to 3 weeks, diligent work must be conducted to rid any area of fleas. Vacuuming will provide two primary benefits:

1. Some pupates will be removed from the carpet area by the vacuum. Every pupate removed by the vacuum means one less adult flea later.
2. Vacuuming may stimulate some fleas in the pupate stage which are more mature to erupt and come into contact with this product. Some experts believe fleas, under certain conditions, can remain in the pupate stage for months, even years.

When this product is used as directed, no new fleas can be produced. The fleas coming into adulthood were probably there prior to treatment with this product or reintroduced by pets. Throw the vacuum cleaner bag away each time the carpet is vacuumed or store the vacuum in an area outside the home.

If a liquid spray is also used with this product, avoid mopping the floors as water will break down the chemical used or completely remove that product. Be sure to check that product for its duration claim and reapply according to label instructions. It is important to trigger fleas in the pupate stage, to erupt while the chemical is most effective. Again, vacuuming is the best method with which this can be accomplished.

Experience indicates a decrease in the number of days the infestation lasts proportionate to the frequency of vacuuming. After the fleas are gone, a regular vacuuming routine can be reestablished. Application of the powder once a year as a preventative treatment should keep flea infestations from reoccurring.

If pets are in the home, they will require treatment with a product registered for use on pets to control fleas. Once pets flea infestations are under control, pets carrying fleas back inside from the outside will not pose a problem. Fleas introduced into the house after treatment of this product will not be able to live or reproduce in the house.
