DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Enforcer Flea Spray for Homes kills fleas, ticks and other insects. It contains a unique combination of ingredients that kills both adult and preadult fleas and prevents preadult fleas from developing into adult fleas. FLEALAR™, a unique ingredient in this product, kills fleas by preventing their development into the adult biting stage. Flea eggs deposited on, and larvae crawling onto, treated areas will not develop into adult fleas. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding and floor cracks. Protects your home from reinfestation and total flea population; your pets and family from bites. A treatment with this spray can provide continuous flea protection for up to 210 days (7 months). Leaves no objectionable odor or sticky mess and, when used as directed, does not stain furnishings and carpeting.

FLEAS: Treat all carpeted areas. Adjust spray nozzle to create a fine spray. Evenly apply a fine mist or spray (avoid wetting or soaking) to carpets, rugs, drapes and all surfaces of upholstered furniture by using a wide, sweeping motion. To kill other crawling bugs (such as ticks, ants, spiders, roaches, carpet beetles and silverfish) spray directly on pests.
